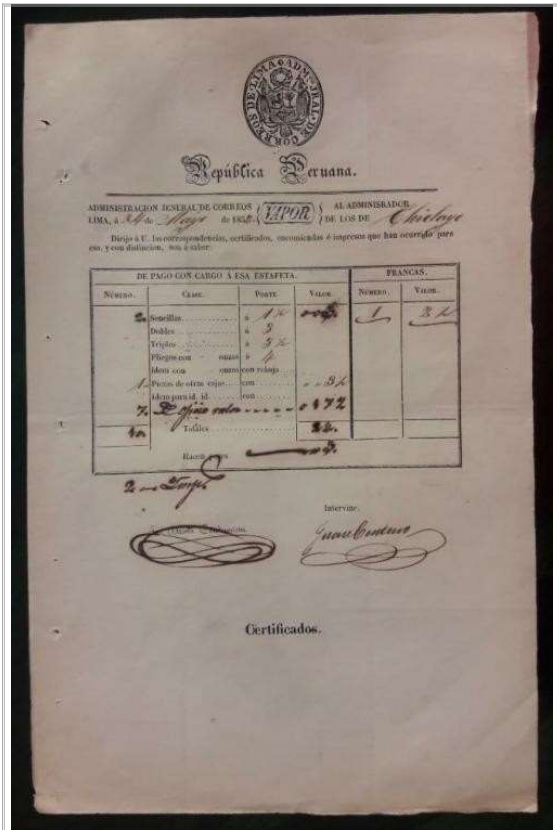


Image: Front view

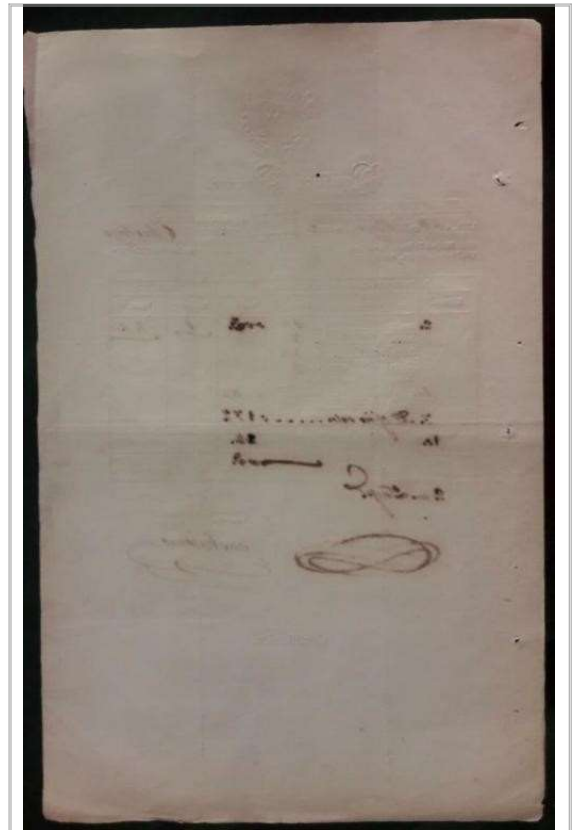


Image: Rear View

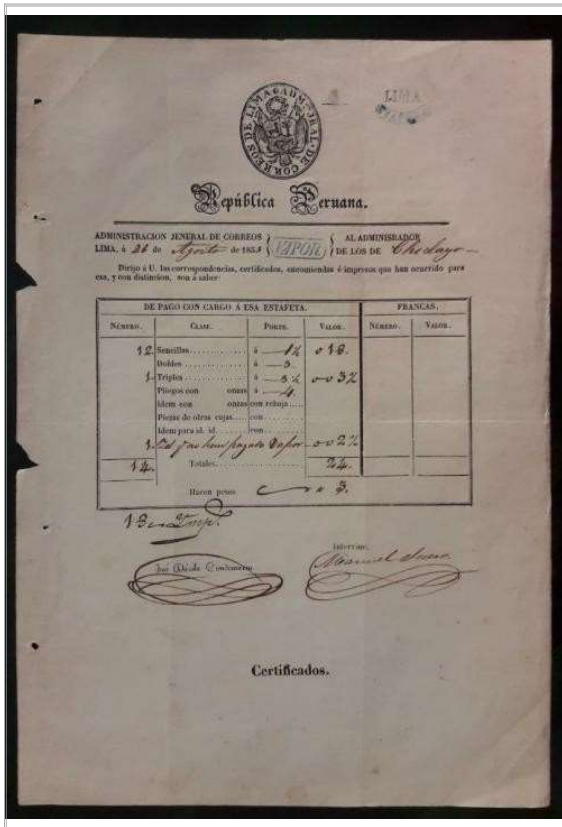


Image: Front view

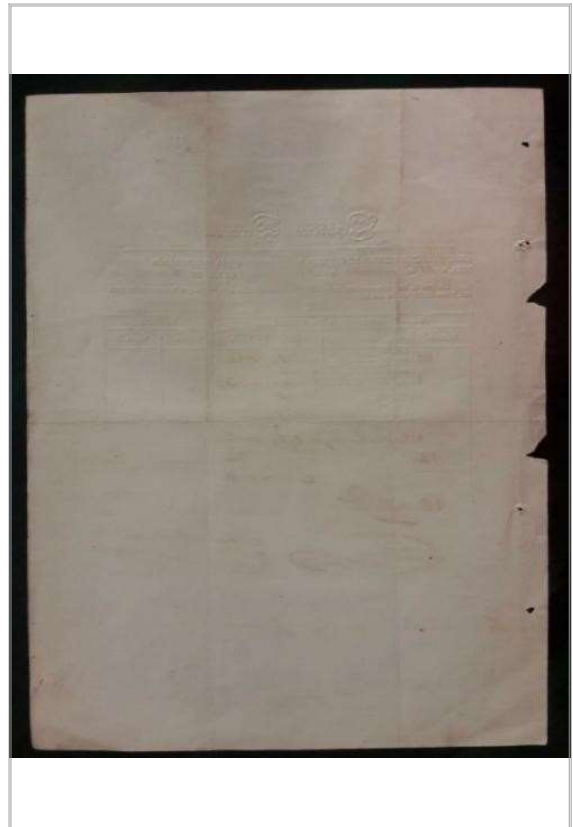


Image: Rear View

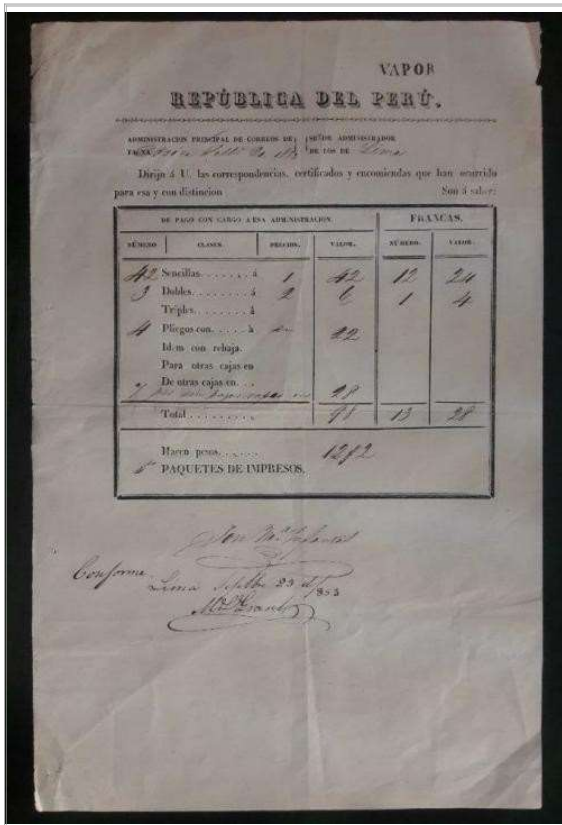


Image: Front view

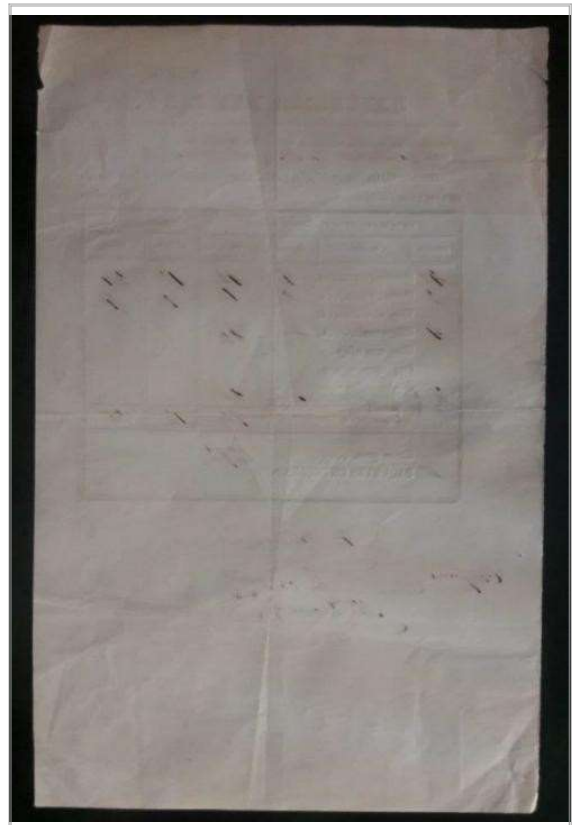


Image: Rear View

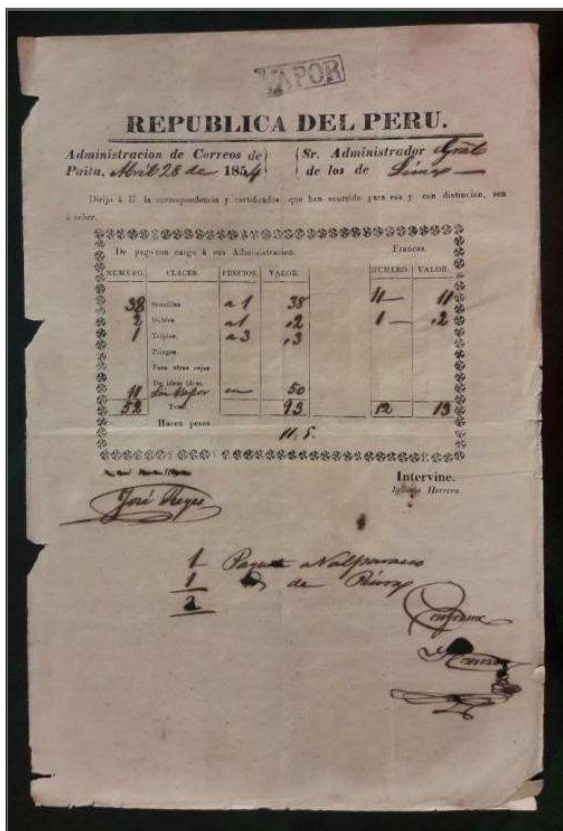


Image: Front view

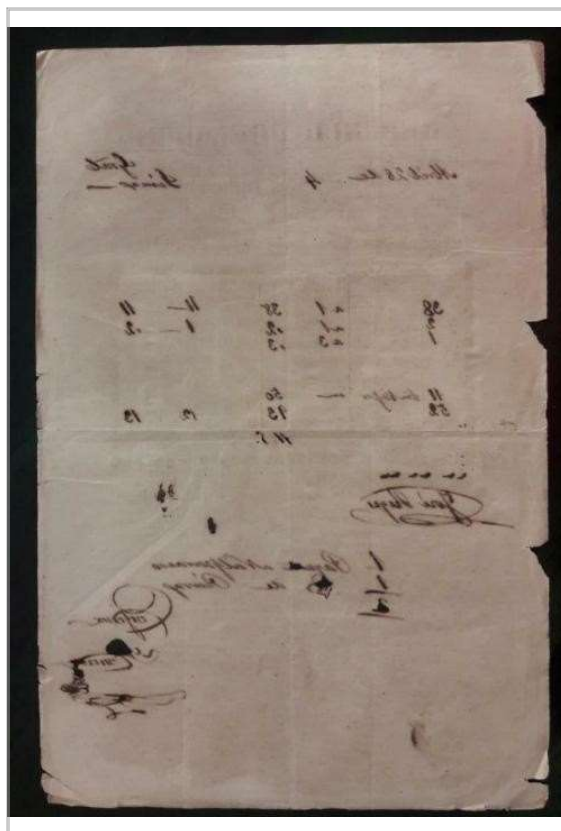


Image: Rear View

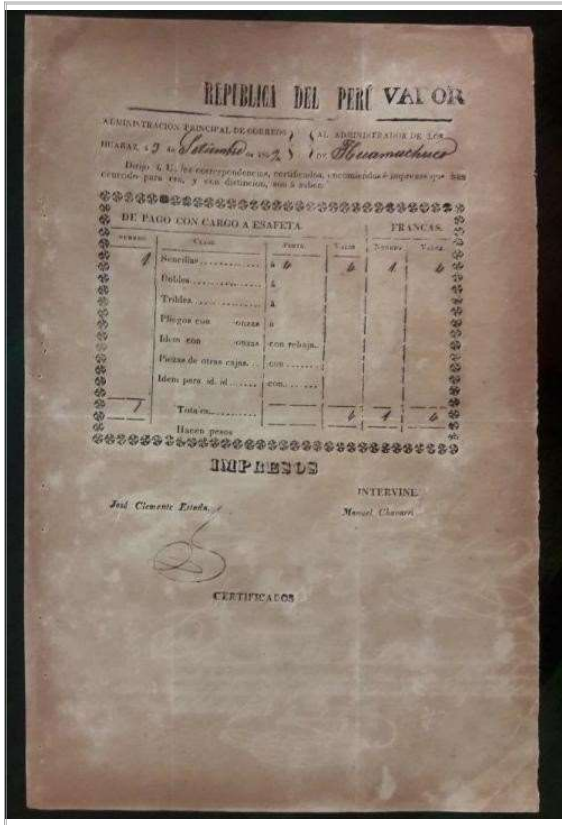


Image: Front view

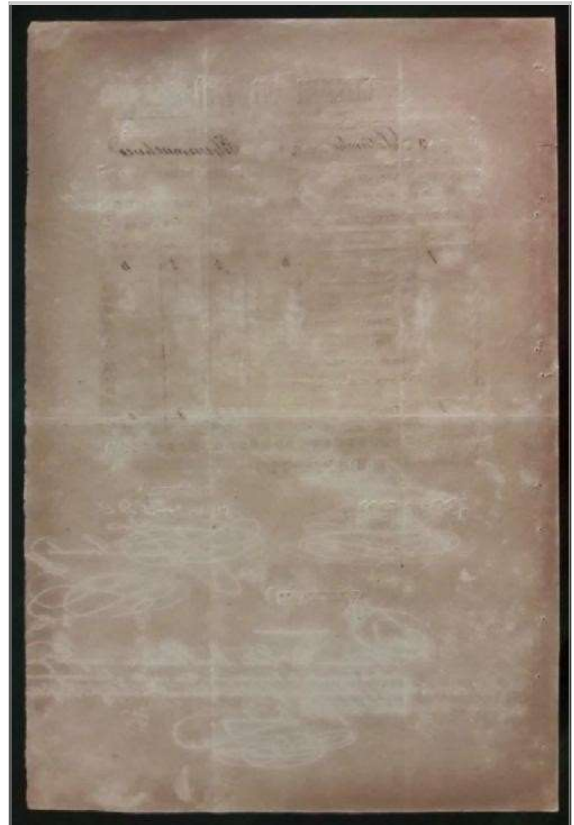


Image: Rear View

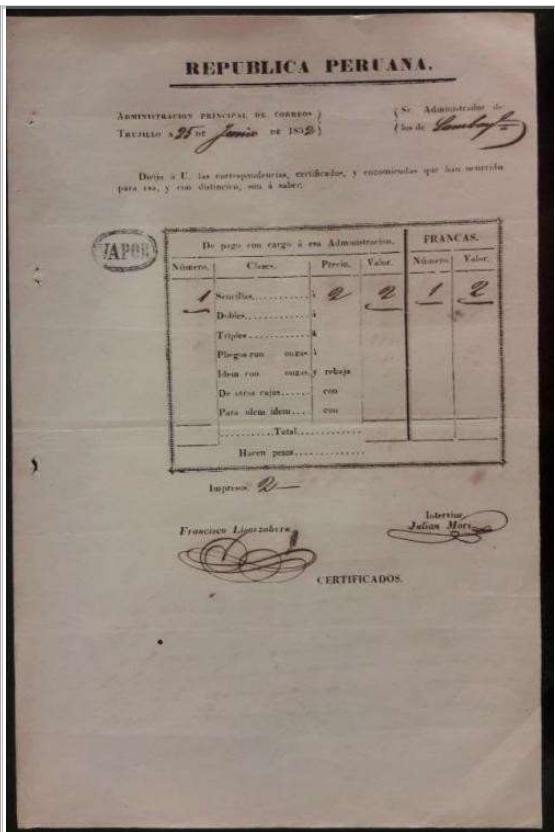


Image: Front view

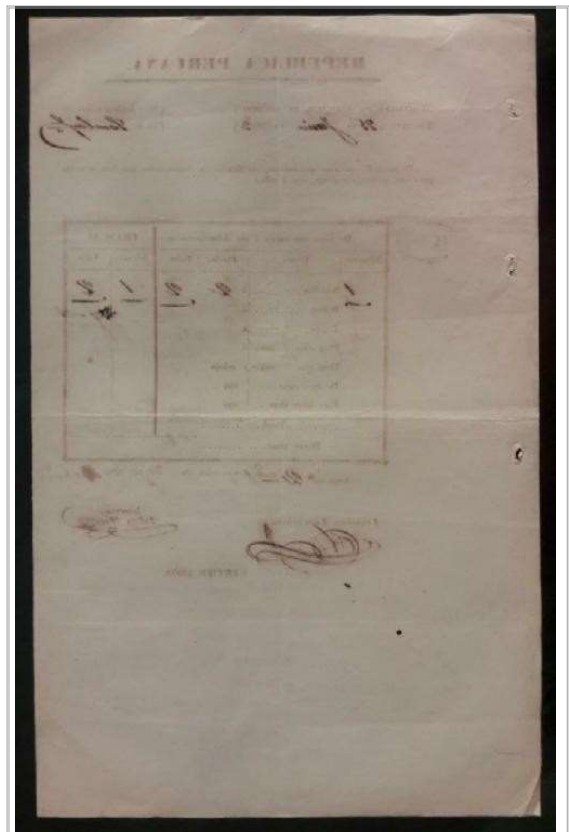


Image: Rear View

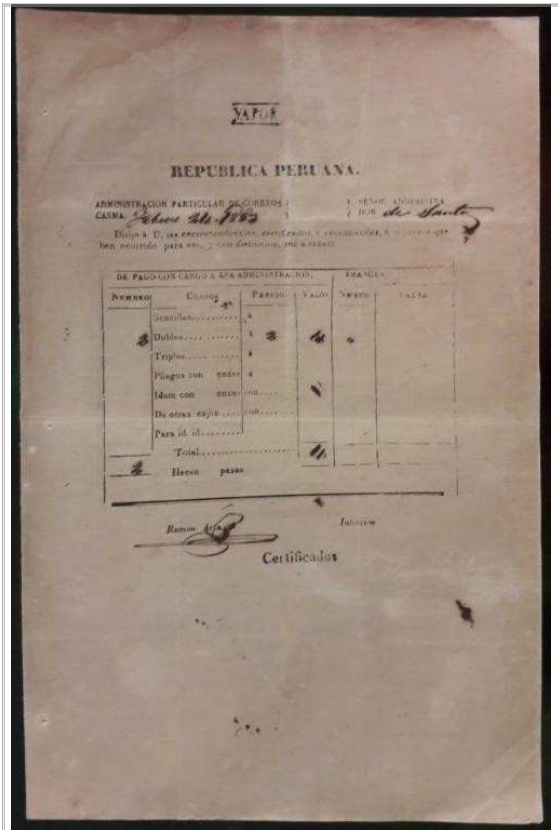

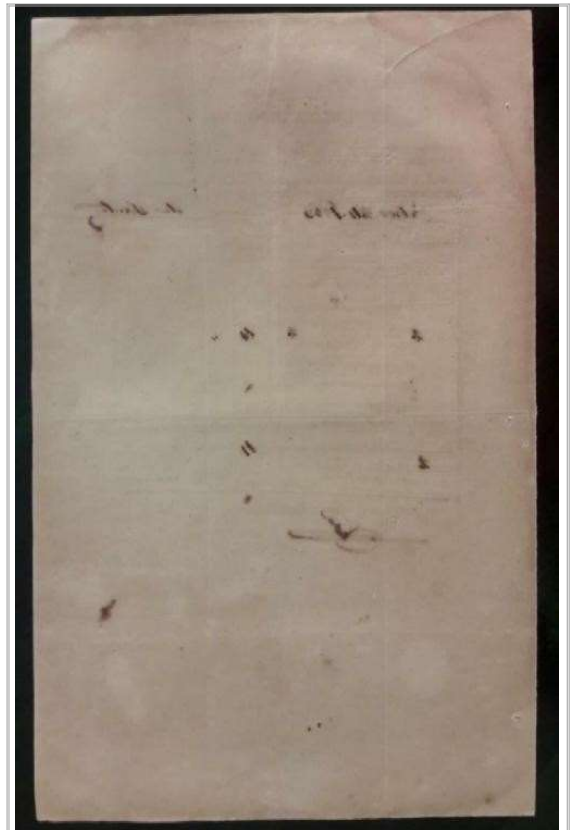


Image: Rear View
